# Document 10 The Status and Management of Flyway Network Sites



#### **Summary**

- New FNS 8 sites (Bangladesh, DPR Korea, RO Korea, Myanmar, New Zealand),
   Updated SIS 7 sites, No new Sister Site since MOP9
- Update the outdated and missing Site Information Sheet (SIS) and maps. 89 SISs out of 141 (63%) sites were missing and outdated [ANNEX 2]
- Draft the updated Process for Reviewing the SIS and Map for new Flyway Network Sites (FNS) [ANNEX 3]
- Approve the Secretariat to provide small funding at the time of designation of new FNS to prepare materials (e.g leaflets, posters and sign board with EAAFP logo) to raise awareness of the Site, and to work with Partners to allow the use of the EAAFP logo on goods and services provided by the local community at FNS

#### Developing a new review process of new FNSs

EAAFP Secretariat - Science Officer conducts an in-house review, then refers the nomination to the Working Group chairs and/or at least three relevant experts (for 14 days) to seek comments on the provided justification of the criteria met and other scientific aspects of the nomination.	EAAFP Secretariat and the Science Unit reviews the SIS and map, then refers the nomination to the Technical Committee and relevant Working Group chairs (for 14 days) to seek comments on the provided justification of the criteria met and other scientific aspects of the nomination  - Any comments on the SIS or map are referred back to the nominating Government Partners who revises the SIS and/or map as appropriate. This review process continues until all the comments are resolved
EAAFP Secretariat & nominating Government Partner - Communication to finalize the SIS with further clarification or additional information as dictated by outcomes of the referralp	
EAAFP Chair  - The Secretariat advises the Chair of the Partnership on the nomination, showing the results of the review process, and requests the Chair to endorse the nomination by writing formally to the nominating Partner about the official inclusion of the site in the Network.	EAAFP Chair  - The Secretariat advises the Chair of the Management Committee on the nomination, showing the results of the review process, and requests the Chair to endorse the nomination by writing formally to the nominating Partner and notifying them about the official inclusion of the site in the Network

Government Partner & Local Government/Management Authority - Announcement of the inclusion of the site in the Network Delivery of the Certificate to the local government and/or management authority, with a small presentation ceremony where possible	



#### Improvement of Raising Awareness for new FNSs

- Branding the international importance of the FNS at both national and local level →
  On a trial basis, Secretariat wants to provide a small funding to a new FNS to
  prepare promotional materials (e.g leaflets, posters and signboard) → Raising
  public awareness of the sites as a FNS in the EAAF First Case: Avon-Heathcote
  Estuary/Ihutai (USD 1,000)
- The EAAFP logo is allowed to be used on a trial basis for next two years to brand the products (e.g. rice, fish, tourists product) and services (e.g home stay) → Giving the profits go back to local community for their benefits and the benefit of the site
