6. Asian Development Bank Regional Flyway Initiative (attachment 3 – MOU draft with ADB)

The RFI is a long-term financing mechanism for the EAA Flyway with an aim to mobilize large-scale financing (~USD 3 Billion) and international support to protect the priority wetlands of the East Asian-Australasian Flyway (EAAF) in the countries of East and Southeast Asia, while leveraging on their co-benefits for coastal communities. This program was initiated by Asian Development Bank partnering in 2020 with EAAFP Secretariat and BirdLife International. This initiative will contribute to achieving the objectives of the Partnerships' Strategic Plan 2019-2028 and help mobilize large scale financing for conservation of Flyway sites but also the economic development of developing country Partners in SE Asia. Overall, the RFI aims to mobilize finance for \$3 billion in investments for wetland protection and sustainable management for the EAA Flyway for 30 years or more. In July 2021, ADB opened a call for tenders for Technical Assistance. BirdLife International was selected as a lead contractor for the TA project that starts in mid-2021 to finish by end of 2023.

The EAAFP Secretariat is expected to play a critical role in overseeing the Technical Assistance and also supporting coordination of country engagement. So far, the Secretariat has helped to bring stakeholders including SE Asian Country Partners, China, Conventions (CBD, Ramsar, UNFCCC) together to call for joint efforts to mobilize resources for conservation of migratory waterbirds and their habitats in the EAA Flyway and this will continue for the successful implementation of the projects.

<EAAFP engagement in RFI>

The EAAFP Secretariat's involvement are on TA development and the EAAFP Country engagement.

- 1) The RFI Technical Assistance (TA) 2021-2023; With the estimated to cost \$1,000,000, the TA will deliver three key outputs by the end of 2023 (link).
 - Output 1: Institutional capacity for understanding East Asian-Australasian Flyway wetland values enhanced regionally
 - Output 2: Regional Flyway Initiative investment framework for priority East Asian- Australasian Flyway sites prepared.
 - Output 3: Regional Flyway Initiative sustainable financing mechanism developed.
- 2) The linkage and contribution of RFI to EAAFP Strategic Plan: The RFI TA seeks to support and build on the objectives of the EAAFP Strategic Plan 2019–2028 and scale up the implementation of the EAAFP Strategic Plan. Table 1 below is a TA results chain extracted from Appendix 1 of the TA report 'DESIGN AND MONITORING FRAMEWORK'.

3) The role of the EAAFP Secretariat

- 1. TA Development (technical): The Secretariat is invited join the TA technical team to provide inputs on site selection framework and needs assessment. >> Doug, Yoon and a junior researcher (to be hired) funded by a TA budget allocation from BirdLife International.
- 2. TA Development (non-technical): provide inputs on co-benefits, investment framework, and sustainable financing mechanism and all other TA outputs that are linked to the implementation of EAAFP's Strategic Plan including consultation with other EAAFP Partners and supports in developing technical assistance activities. >> FsC provide advice

The Country Engagement: Organize an annual EAAFP country workshop in cooperation with ADB and BLI, possibly via CBD, CMS, Ramsar COP and EAAFP MOP. >> ADB is expecting to cooperate with the Secretariat for country engagement. Liaison with ACB and Ramsar Secretariat would be important. (Seeking MC's advice).

< Establishment of EAAFP Advisory Group>

Per the recommendation of the EAAFP Management Committee held on 1 April 2021, Secretariat is working to formalize a small advisory group reporting to the MC on the ADB Flyway Initiative (Action 7.1). The advisory group will provide strategic direction to the Secretariat and report to MC via the Secretariat.

7. Extra Consultancy Projects coordinated with the Secretariat

- EAAFP Migratory Waterbird Conservation Status Review (WI) (MOP10. DD12, budget from Secretariat)

Wetland International has completed the update of the population estimates for the EAAF and the polygons of the distribution of these populations. While the SU and the Secretariat circulated the draft estimates and distribution polygons to Working Groups, Task Forces and other experts, WI reports that feedback has been limited – disappointing outcome.

- Guidelines for National Partnership, Site Partnership and Sister Site Program (MOP10. DD08/09, budget from Secretariat)

At EAAFP MOP10, Partners adopted decisions that instructed EAAFP Secretariat to develop guidance material on National and Site Partnership and Sister Site Program in consultation with Partners. The Secretariat signed a consultant contract with Ms. Jennifer George based in New Zealand. The webinar and respective interviews with government partners and relevant stakeholders were organized till November 2021 and currently, the draft for the three guidelines is ready and under review by reviewers including some Partners and the CEPA Working Group. The Secretariat is pleased with the four documents (Site Partnerships, National Partnerships, and the Sister Site Program) prepared by Jennifer. The CEPA Working Group has provided some input on the drafts. The final

documents from the consultant are expected to be with the Secretariat in a few weeks. The Secretariat recommends circulating the documents to Partners well in advance of MoP11. If there is to be an online "workshop" in mid-2022 with Partners that it would be a valuable opportunity to discuss these guidelines.

- RO Korea Hwaseong Flyway Network Site Project (USD 92,000 annual from Hywaseong Gov't)

After the designation on Hwaseong FNS (listing in potential WH sites – Phase II) in late 2018, with the special request by the local government to raise awareness and make an efficient management plan, the Secretariat hired a local project coordinator to work in the Programme Team to implement the various projects with government authorities, experts and local NGOs. In 2020 – 2021, we helped to raise the overall profile of the Hwaseong Wetlands by improving the monitoring data set through the survey and warden training, cooperation with international communities and public citizens and organizing the Hwaseong symposiums. Through the production of the guideline for the management of Hwaseong Wetlands in early 2021, the part of the Hwaseong Wetlands FNS was designated as a national wetland protected area, it's being considered for Ramsar nomination. In addition, the remaining part of the area has been requested to be nationally protected. Also, in order to support the CMS Far Eastern Curlew Action Plan, the Secretariat supported Hwaseong City to establish a Far Eastern Curlew Network in the Korean Peninsula among Hwaseong, Incheon Yeonsu, Seocheon Local Governments. These areas have the key habitats and recently the first national-scale census on FEC in ROK was completed. In addition, the Secretariat continued to support the long-term monitoring for FEC together with Local NGOs and Local Communities at Important Sites in Sumatra, Indonesia. In 2022, the budget is approved, the main activities are planned in a collaboration with Partners as follows

- 1) Sister Site twinning
- 2) Supporting to get an international consultation (e.g. WWT, WWF) on a site plan around/of Hwaseong Wetlands
- 3) Local activities for the conservation of Hwaseong Wetlands
- Incheon Hong Kong Sister Site program implementation (USD 42,000 annual from Incheon Gov't)

After Incheon – HK twinning the sister site program, the Secretariat supported Incheon City to implement some relevant projects until the stabilization of the communications and activities among countries. We focused on assisting in the improvement of BFS monitoring data analysis through the national BFS census, establishing a national BFS census, establishing a national BFS Network. Several CEPA materials are planning to develop e.g., Video, BFS game. The annual BFS forum will be organized. In 2022, the budget is approved, depending on the situation of COVID-19, the Secretariat will try to enhance the exchange program for school students and government officials, and continue to support the survey for national BFS census and CEPA activities
