INTRODUCTION



During MOP10 D4 was approved and amended ToR and RoP

The adopted organisational structure in MOP10 and recognised that both the Technical Committee and Finance Committee should be treated as sub-Committees of the overarching Management Committee.

TSc compiled a comprehensive list of tasks instructed of it from a) the TSc Terms of Reference (MOP10 Decision 4); b) the Strategic Plan 2019-2028 (MOP10 Decision 1), c) other MOP10 Decisions; and d) TSc meeting discussions, and the role(s) of the TSc and other FP mechanisms in task delivery.


