# Background

The SSAP identifies national and international management and research actions across key Range States to ameliorate anthropogenic threats, such as:

- Bycatch in fishing gear;
- Illegal hunting;
- Prey depletion;
- Heavy metal contamination;
- Marine debris; and
- Weed encroachment on roosting habitat



# **Essential and High Priority Actions**

- Prevent the introduction of a new disease to the breeding site;
- Identify and protect foraging areas;
- Maintain or improve current policies or legislative to ensure all threats are effectively managed;
- Prevent disturbance to terrestrial habitat –maintain or improve the quality of habitat;

## **Essential and High Priority Actions**

- Implement monitoring to support adaptive ٠ management
  - Monitor and report on the implementation and effectiveness of actions
  - Monitoring data is made publicly available; and •
- Undertake research to assist management and understand threats
  - Movement patterns
  - Location of foraging and roosting areas •
  - Exposure and impacts of environmental contamination, marine debris, prey depletion, hunting and bycatch.

# Decisions

- 1. Adopts the International Single Species Action Plan for the Conservation of the Christmas Island Frigatebird (*Fregata andrewsi*) as submitted to MoP11 at Attachment A;
- Notes that the Plan will be submitted to the 14<sup>th</sup> Conference of Parties of CMS in October 2023 for endorsement;
- 3. Urges Ranges States, Partners and other stakeholders to implement relevant provisions of the Action Plan as a matter of priority;

## Decisions

- 4. Encourages Partners to provide technical and/or financial assistance to support activities outlined in the Plan;
- 5. Instructs the Secretariat to make the Plan available on the EAAFP website;
- 6. Further instructs the Secretariat to bring the Plan to the attention of all Range States and relevant stakeholders; and
- 7. Requests the Seabird Working Group to monitor the implementation of the Plan and to report on progress at MoP12.
